# Morsani College of Medicine Faculty Council Meeting Tuesday, October 24, 2017 Meeting Minutes

### 1. Approval of FC September 26, 2017 meeting minutes

The minutes were unanimously approved.

# **II. MCOM APT Committee Annual Report**

Burt Anderson presented a summary. Total of 29 advanced rank appointments approved by the MCOM APT Committee. Total of 54 tenure and promotion applicants were reviewed; with 2 tenure earning, 2 scientist educator, 9 research scientist, 3 collaborative research scientist and 39 clinician educator. All were approved for promotion and/or tenure after 3 were denied but overturned after Chair appeal session, and the decision of the Sr. Vice President. Areas of concern: lack of teaching evaluations, and letters of recommendation. Also the creation of department criteria.

## III. Update on CAMLS

Paul Ayers presented update on CAMLS - in regards to the business development and marketing aspects aspects of CAMLS. Discussion included summary of businesses/organizations/ associations that visit CAMLS; high school program that invites high school students for a one-day opportunity to see what medical school is like. Downtown Tampa and CAMLS – pathway runs under Selman Expressway. Provides a safe environment for walking. Increased USF integration; increased USF signage. Follow CAMLS on social media. Invited faculty to participate in a survey to help connect all of USF Health and regional and national medical device companies, medical societies, etc. Possibly to bring conferences to CAMLS.

# IV. Update on PhD and Pre-professional programs

Presented by Robert Deschenes. PhD and MD/PhD programs – 100 students; MS programs – 900 students; postdoctoral fellowships – 44 at MCOM and 85 at Moffitt.

PhD program. Umbrella program. Incoming students rotate through variety of programs before deciding on program of choice. Will work looking at trends such as declining interest in PhD and an academic career. Change in NIH R01 funding in regards to age. Presently more grants are awarded to those over 66 years of age as compared to 1980 where grants were awarded to those 35 and younger.

NIH BEST (Broadening Experiences in Scientific Training) – call for grants 5 years ago. Will determine where BEST grants were awarded and to retrieve information as a result of the grants to see where PhD students can work towards new careers, such as Science Non-Related Research, Government Research, Academic Teaching, Industry Research, and Non-Science positions.

MS Programs and Concentrations. To include 5 major groups: MS in Medical Sciences (MSP3, Health Sciences, Anatomy, Molecular Medicine, Aging and Neurosciences, Metabolic and Nutritional Medicine, Women's Health); IMS; Biotechnology MS, Bioinformatics MS, and MS Health Informatics. Underdevelopment past 10 years.

Graduate Student Enrollment. Past 10 years, enrollment has increased from total enrollment of 199 students to 986 students, with the majority of enrollment in the MS programs. Enrollment varies with programs. MS Tuition Revenue. AY 10/11 was about \$3.5 million, now close to \$8 million.
