#### ABOUT FLORIDA HERI

To better understand health disparities and develop approaches to promote health equity in the state,



the Florida Department of Health, including the Biomedical Research Advisory Council (BRAC) and the Office of Minority Health, convened a group of more than 30 scholars and

community stakeholders to develop the Health Disparities Research (HDR) Agenda for Florida.

Florida's Health Equity Research Institute (HERI) was established to implement the recommendations from the HDR Agenda through proactive collaborations among academic institutions, health care providers, government organizations, community-based organizations and funding organizations. Thus far, 17 universities and community organizations are affiliated with HERI. Under the leadership of Florida State University, (Penny Ralston, PhD), HERI was approved by the Board of Governors.
