Committee Chairs:

- Full-time Faculty
- Serve 1-year terms and no more than 2 consecutive terms
- APT Chair must be tenured
- Committee Chairs will notify the Chair of Faculty Council whenever a vacancy occurs on their committee.
- Committee Chairs will notify the Chair of Faculty Council at least seven working days in advance of a regularly scheduled Council meeting of any business items to be included on the Council agenda.

APT Committee:

- 20% of total faculty
- Members elected from full-time faculty; 50% tenured
- One member from each faculty rank: instructor, assistant professor, associate professor, professor
- One-half elected by ballot in even years and one-half in odd years
- If not elected to the committee, the Member-at-Large/Faculty Senator serves as ex-officio.
- Chair must be tenured.

Committee Quorum:

- Majority of membership (50% + 1)
- Ex Officio members are counted in quorum

Faculty Council President

- Must be tenured
- Is an ex-officio member of all committees, but can only vote to break a tie.

Officers (Pres / VP / Sec-Treas / Parlia / Member-at-Large)

- Elected to serve 2-year terms and no more than 2 consecutive terms
