In addition, John S. Curran, MD, Senior Executive Associate Dean for Faculty and Academic Affairs, served as the administrative liaison. The administrative assistance of Ms. Eileen Dinerstein and Ms. Patricia Barrett is gratefully acknowledged.

The Committee conducted regular monthly meetings on the third Wednesday of each month at 7:30 a.m. At these regular monthly meetings throughout the year, the Committee considered the requests for 17 faculty appointments at advanced rank (4 Tenure Earning, 6 Clinical Educator, 1 Clinical Scientist, 6 Courtesy Clinical Educator) and 1 request for joint appointment. There were 7 requests for mid-tenure review.

In addition, the Committee held an extended meeting in December 2014 to review applications received during the 2014-2015 promotion and tenure cycle. The Committee reviewed a total 54 applications. The following list describes the categories of applications and the committee's recommendations.

Promotion and Tenure Applications:

- The denial was overturned at the committee level

Other business discussed by the Committee included a review of the current criteria for promotion and tenure at the MCOM. The Committee developed revisions to the promotion and tenure guidelines along the Tenure Earning pathway. These revisions were submitted to the MCOM Faculty Council for consideration and approval. The Committee developed revisions to the make-up of the MCOM APT committee to more accurately reflect our faculty body. These revisions were approved by the MCOM Faculty Council and will be implemented with the 2015-2016 MCOM APT Committee. Lastly, the Committee began to review guidelines for faculty promotion for site-specific "pre-fixed" academic titles.

The Committee was represented by Dr. Kruk at the annual Appointment and Promotion Workshop (June 2014) and by Dr. Kruk at the annual reviews for promotion by the Voluntary Faculty Committee (November 3, 2014 and May 19, 2015).
