October 2009

- Nomination and election of COMCOR chair
- FY 09-10 COMCOR initiatives
- Research Day 2010 plans
 - •Date and venue for the 20th Annual USF Health Research Day were announced on Friday, February 19, 2010 in the USF Health Rotunda. Research Day planning commenced with emphasis on student and trainee research project posters and presentations, a Keynote speaker and an award ceremony/reception. Dr. Marty started working on finding a Keynote speaker. Committee members provided input into the plans for Research Day.
- Executive Committee on Research and Education-ECRE
 - •The establishment of ECRE was relayed to COMCOR. ECRE is a committee tasked toreport to the Dean. The chair of the COMCOR will sit on this committee, interact with the department chairs and provide input on research and educational matters to the Dean.



November 2009

 - •The committee was asked to suggest possible invitees from USF divisions. With recent queries on postdoctoral issues, it was thought representatives from the graduate school, human resources and the postdoctoral office could provide guidance on the current status of USF research fellows.

 - •Dr. Marty spoke on the Vice Dean for Research search and the Executive Committee for Research (ECRE), Dr. Borlongan was assigned to sit on this committee, interact with the Dept. chairs and provide input on research and educational matters to the Dean. Dr. Marty and Dr. Deschenes met to discuss research infrastructure, mentioned possible funding opps. from NIH and NCRR to pursue. Also pursuing a USF VAH collaborative for a joint research bldg on campus that would benefit from COMCOR involvement.



December 2009

 Post doctoral issues addressed by Dr. Karen Liller, Eric Andersson, and Diane Laya

COMCOR received guidance on the following issues:

- •Wages and benefits for postdocs to be comparable to those offered experienced technical staff.
- •Soft benefits such as library and gym access for PD family members.
- •Representation from the Sciences on PD planning committees.
- •Flexibility in benefits packages that can be offered .
- •Postdoc orientation- formation of a Post doc association.
- •Request HR assistance with Professional Development of senior PDs with job searching, interviewing, funding opportunities.
- Update on Grad student/MD student GPA's provided by Dr Michael Barber
 - •Discussed the need for obtaining a training grant, need to find a niche to fill by determining our strengths in our teaching mission such as educational areas like Infectious Diseases

- •Dr. Marty also gave the committee the proposed model for the Research Faculty Salary Enhancement Policy for comments.

2009-2010 Summary of COMCOR Achievements

- Successful hosting of USF Health Research Day, highlighted by recognition of Dr. Joseph Krzanowski
- ■COMCOR role in ECRE becoming recognized, in particular COMCOR efforts to improve the status of USF postdoctoral fellows
- A more active role is expected from COMCOR moving forward with opportunity to present urgent faculty issues at ECRE meetings
