

**Paul E. Spector** is a distinguished professor of industrial-organizational (I-O) psychology at the University of South Florida. He holds a courtesy professor appointment in the Muma College of Business at USF, where he teaches in the executive doctor of business administration (DBA) program. For 14 years he was the director of the NIOSH funded Sunshine Education and Research Center's Occupational Health Psychology doctoral training program. He is the Associate Editor for Point/Counterpoint for Journal of Organizational Behavior, Associate Editor for Work & Stress, and is on the editorial board for Journal of Occupational Health Psychology. He serves on the advisory board for Occupational Health Science, a new journal being published by the Society for Occupational Health Psychology. For more than 40 years he has studied the negative things people do at work (counterproductive work behavior) and the negative things that happen to them (accidents/injuries, mistreatment, stress, and violence). He also does work on research methodology, with a particular interest in the effects of method variance, and issues dealing with data-based conclusions, such as the proper use of control variables. His work has appeared in major research outlets in the field of I-O Psychology, Occupational Health Psychology, and Management.



# Dr. Heidi Radunovich

Associate Professor and Extension Program Director for UF Engagement Human Development

Dr. Radunovich joined the Department of Family, Youth and Community Sciences in 2002 as an Assistant Scientist at the National Rural Behavioral Health Center for 4 years. She started her position as an Assistant Professor of Human Development in July, 2006, and was promoted to Associate Professor in 2013. She has recently taken on the role of Extension Program Director for UF Engagement. Her current workload is split among Cooperative Extension (65%), teaching (25%), and research

(10%). In the area of Cooperative Extension, areas of programming include stress and family stress (including disaster stress, military families, coping with chronic illness and disabilities), motivational interviewing, preparation for college, and childcare provider education. Within the area of teaching, Dr. Radunovich teaches an undergraduate course, Contemporary Family Problems, and graduate courses, Working with Military Families in the Community Context and the introductory graduate seminar, Human Resource Development. She also provides undergraduate academic advising, and works with graduate students in their research and project development. Her research foci include family stress, youth risk behavior, college success, and academic integrity.

Dr. Radunovich completed her undergraduate degree at Washington University (majoring in Psychology and Spanish). Her M.A. and Ph.D. in clinical psychology were earned at the University of South Florida. She is also a licensed psychologist in the state of Florida. Dr. Radunovich is married and has a daughter.
