## **Budget Update**

- The State budget remains challenging
- For FY 2009-10, COPH was required to take a reduction in recurring state funds of \$681,422
- Over the last two plus years, total E&G recurring reductions total \$1,778,235
- This fiscal year, all USF units were assessed a 10% "tax" on their E&G carry forward dollars
- F&A return for FY 07-08 reduced to 66% of 30%; no news on plans for FY 08-09 and beyond





# Mixed Blessings

- COPH received \$516,124 in stimulus funds to temporarily offset our budget reduction
- These funds allowed us to avoid layoffs resulting from the most recent reductions
- Unfortunately, these funds are temporary and require us to plan for a likely grim future
- Enrollment increased again, though we have not yet received all of the tuition dollars we generated





#### The news is not all bad

- The College all-source budget continues to stay around \$40 million, despite the state reductions, due to our growth in other funding categories
- In FY 08-09, COPH faculty generated \$3,083,765 in F&A, an increase of 23% from the previous year
- Gifts to COPH Foundation accounts were about \$221,982, an increase of \$111,000 from the prior year
- COPH auxiliary programs collected almost \$1.5 M in revenues, a 17% increase over the prior year





#### Research in COPH

- COPH faculty have now generated more than \$275M in external research dollars since our inception
- COPH Faculty submitted 115 proposals for \$80.4 M in 2008-09
- Total COPH awards in 2008-09: \$18,179,460
  - 68% of 08-09 awards were federal
  - 20% increase in private partnership awards
- Research expenditures in 2008-09: \$19,804,260
  - 88% of the expenditures were federal



# American Reinvestment & Recovery

#### Act

- COPH faculty submitted 18 proposals through ARRA processes, including 10 Challenge grants
- USF has received 17 NIH awards via ARRA for \$3.5 M
  - 5 awards (29%) totaling \$1,040,046 to COPH
  - Dr. Rita Debate received her funding through NIDCR
  - Dr. Tom Unnasch, GLH, is one of two faculty at USF to receive multiple awards (both NIAID)
  - Dr. Yangxin Huang, EPB, was the first award recipient at USF (NIAID)
  - Chris Campbell, GLH doctoral student, is USF's only student award recipient to date (NIAID)
- Dr. Deanna Wathington received supplemental Public Health Traineeship funds from HRSA through ARRA
- \$9.6 M lab expansion proposal for GHIDR/IDRB under reviews



# So far, 2009-10 is even better!

- Through Q1 of this year, COPH has received \$6,550,257 in research awards
- This an increase of \$1,252,594 (24%) over where we were at the same point in 2008
- Continued steady flow of grant applications being submitted

#### **Academics**

- DrPH was approved and our first class started Fall 2009
- Our 10<sup>th</sup> Executive MPH Program cohort graduated August 2009; the 11<sup>th</sup> group started in September
- New online MPH degree in Global Disaster
   Management and Humanitarian Relief approved
- Approved new certificates in Environmental Health and Water, Health and Sustainability
- COPH awarded 405 undergraduate minor certificates over the last 3 semesters





#### **Enrollment**

- As of Fall 2009, COPH programs enrolled 659 masters students and 123 doctoral students, an increase of 15% and 10% respectively from Fall 2008
- We taught 32,479 contact hours last academic year at the graduate and undergraduate levels
- At the graduate level, we increased our funded enrollment by 90





# International Programs

- Increased activity in our Panama office
  - Hosted a successful Vivax Malaria Conference supported by the Gates Foundation
  - Hosted numerous groups and individual students from COPH complete field experiences in Panama
  - Had programs from the Colleges of Nursing and Business and The USF Honors College
  - Coordinated a program from the University of Southern California





# Workforce Development & Training

- COPH Faculty & Staff provided training to over 7,600 individuals in Florida and around the globe through such programs as:
  - OSHA and OTI training programs
  - 19th Annual Social Marketing in Public Health Conference
  - 22<sup>nd</sup> Annual Conference on the Physical & Dev.
     Environment of the High Risk Infant
  - EOH's Sunshine Educational Resource Center programs
  - Florida Center for Public Health Preparedness
  - Center for Biological Defense
  - Center for Social Marketing Field Schools





# 2008/2009 Faculty-Staff Campaign

- SIXTY PERCENT Participation Rate
- Highest participation rate of any college at USF except for the Honors College
- THANKS to all of our faculty and staff who made the campaign a success
- Upcoming 2009/2010 Campaign starting this fall





## Student Awards & Support

- Since July 1, 2008 the College has provided:
  - 66 Book Scholarships (formerly LACS)
  - 29 SHARP Awards
  - 6 Student Research Awards
  - 12 Public Health International Travel Awards
  - 1 Public Health International Research Award
  - Funding to support a student placement through the CDC/ORISE fellowship program





### Student Awards & Support

- In FY 2008-09, COPH provided over \$1.6 M support to COPH students through:
  - Graduate Assistant stipends
  - Tuition and fee waivers
  - Scholarships & Fellowships
  - Graduate Assistant Health Insurance Premiums
- This was an increase of over \$200,000 from the previous year





#### **CEPH Site Visit**

- We are scheduled for reaccreditation in 2011
- Our self-study document is due December 16, 2010
- Our site visit dates have been set!
  - May 16-18, 2011





### **CEPH Self-Study**

- There are 27 criteria
- We must meet them or meet them with commentary to be in compliance
- If we do not meet a criteria or partially meet it we are considered out of compliance
- This could result in revocation or a requirement to complete a series of interim reports





# **CEPH Self Study**

- 27 criteria are grouped into 4 areas
  - The School of Public Health
    - Mission, evaluation & planning, institutional environment, governance, organization, resources
  - Instructional Programs
  - Creation, Application & Dissemination of Knowledge
    - Research, service, workforce development
  - Faculty, Staff, and Students
    - Qualifications, policies & procedures, diversity, advising & career counseling, recruitment and admissions





# **CEPH Self-Study**

- We have standing faculty committees that have responsibility for faculty, research, and academic issues and associate deans with responsibility for administration & finance, academics, faculty & staff affairs and research
- So that begins to form our "accreditation team"
- As a link between our Strategic Plan and the reaccreditation process, Dr. Robert McDermott has agreed to serve as the lead writer for the self-study





# **CEPH Self-Study**

- We will need for everyone faculty, staff, students, alumni, and community - to actively participate in this process
- Stay tuned there will be more to come!





## Strategic Investments & Initiatives

- To ensure progress toward our strategic plan goals and consistent with our research foci College leadership identified a set of resources that will be used to spark new initiatives in targeted areas.
- Currently we are awaiting the release of some of these expected funds; however, several initiatives are moving forward at this time.



# Strategic Investment & Initiatives: Under Way

- COPH Faculty International Program Development Awards
  - Funds set aside to help defray travel costs associated with international program development
- Early Career Investigator Awards
  - Up to two \$15,000 awards for junior faculty for pilot projects/data gathering research initiatives
  - Deadline for application November 6, 2009





- Professional Development for our Faculty,
   Staff & Students
  - Currently developing a process and criteria within which individuals can apply and be selected to receive funds to support their participation in a professional development activity
- Staff support for CEPH re-accreditation & CAHME accreditation initiatives



# Strategic Investment & Initiatives: Pending

- As soon as the expected resources become available, we will begin the following initiatives:
  - COPH Interdisciplinary Research Development Awards
    - Up to three \$100,000 awards to stimulate interdisciplinary research collaboration & the exploration of innovative ideas
  - Strategic Faculty recruitments
    - Visiting Scholars, soft-funded faculty in targeted areas



# Strategic Investment & Initiatives: Pending

- Scholarships & Fellowships
  - Resources for the support of our graduate students
- Capital Investments
  - To support areas where an investment in capital expenditures is necessary to advance our goals
- PR/Marketing Support
  - Support position to help the College market all the wonderful work done by its faculty, staff, and students



### Strategic Plan

- Plan guides us from 2007-2012, consistent with the USF plan, and CEPH data reporting requirements
- Developed with significant faculty input, steered by Dr. Robert McDermott with stellar assistance from Ms. Barbara Kennedy
- Considerable progress has been made in accomplishing many of our goals, however much works remains to meet our stated targets
- Data is still coming in on the 2008-2009 academic year, most notably though the new on-line FAR





### Strategic Plan

- As with accreditation, there are aspects of this plan that will require deliberate effort
- Our strategic investments are designed to get at some of these
- Others will require thoughtful consideration by interested faculty
- Workforce development, competencies, assessment, diversity





#### Values

 One area required by CEPH that we failed to attend to while crafting the strategic plan:

A statement of values that guide the school, with a description of how the values are determined and operationalized





#### Values

- Over the next few months, we will engage in an iterative, web-enhanced process, to determine what we believe are the core values that guide us in our work, our interactions, our communications and our passions
